CoSN K-12 Community Vendor Assessment Tool

Specially developed for K-12 districts and education service groups, the CoSN K-12 Community Vendor Assessment Tool (K-12CVAT) is provided to assist school leaders in measuring the risks associated with purchases from vendors. Prior to committing to a purchase, school leaders are advised to ask the vendor to complete a K-12CVAT assessment to confirm that the vendor has the necessary information, data and cybersecurity polices needed to protect a school system's information and their stakeholders Personal Identifiable Information (PII).
